Synopsis:

The victim received several threatening text messages from the suspect. A report was taken and will be forwarded to the District Attorney for review.

Details:

On 07/02/12 at 2000 hours I responded to 6785 Onyx Trl, Pollock Pines, regarding a threatening text message report. Upon my arrival, I contacted the victim (Kari Guthrie) who told me the following:

Kari stated she and (suspect) have been acquaintances since high school; however they have not always kept in touch. Kari said went to high school with her, her husband, and the father of Linnea Lomax, who has recently gone missing. Kari has been assisting with the search and rescue in the Sacramento area in an attempt to locate Linnea. Kari was contacted by who offered to assist with the search for Linnea, and he has also gone to the Sacramento area to help.

Kari said works in the field of politics. Kari said the more helped with the search the more it appeared to her and others that was making the search more about him and not Linnea. Kari said on 06/30/12 she told she did not want to be around him and believed he was assisting with the search for Linnea for the wrong reasons.

On 07/02/12 at 1642 hours, began text messaging Kari. was upset and said some obscenities in his messages and also told Kari "screw you." Kari told that she was sorry he felt that way and said she would be praying for him. Kari said she believes possibly has a drug and or alcohol problem. Kari said two of the last messages she received from the she believed were threats. Kari showed me the messages and I saw the following:

The first message said, "I hope someday it's your daughter. Don't bother asking for help" and the second message said, "You think it's bad now. It's just begun." Kari believed the threats were directed at her and her daughter, and was immediately overwhelmed with a sense of fear that something was going to happen.

On 07/02/12 at approximately 2100 hours, I contacted via telephone. Prior to answering the telephone I activated my audio recorder to record our conversation. Told me the following, in summary;

answered the phone and identified himself. I told who I was and explained to him why I was calling. I me immediately said, "Tell her to kiss my ass, she's full of crap" referring to Kari. I asked about the message where he hoped Kari's daughter would go missing.

said he grew up with Craig Lomax, whose daughter is missing (Linnea), and has been working on the search and rescue team for the past five days straight. Said because he has media contacts, the family asked him to contact the media. Went on to say that Kari and her "stupid little bitch friend Roseanne" have been telling the volunteers that he has to be in the middle of things to look important. Said they were "talking all this shit to the volunteers causing all kinds of trouble" when all he wanted to do was focus on finding Linnea. Said he told Kari to "take your petty ass bullshit somewhere else."

said Kari began text messaging him today saying he needs serious help. said he told Kari she could "take her little prayer" and "bullshit" that he needs help and stay out of his life. reiterated that the main goal of the search was to find Linnea and told Kari she should stay away from the search. said today he finally became so fed up with Kari and Roseanne, he told Kari they should go down to Sacramento and search for Linnea for 20 hours a day, and he would go home. said, "And someday, I hope it's your daughter. Don't fucking ask me for help and don't call me because you need a friend, because I won't be there for you."

I asked about the second message where he said, "You think it's bad now. It's just begun." said he said that because they want to get into a "pissing match" and additionally said, "It's them playing petty bullshit." Our conversation ended shortly thereafter. The audio recording will be attached to this report for a more detailed statement.

On 07/03/12 at approximately 0300 hours, I responded back to Kari's residence because she had received an additional text message from the at 0248 hours. Kari showed me the message and it said, "Hahahahaha game on." Kari said when she received the message the overwhelming fear that was going to do something to her or her daughter returned. Kari said she and her husband are contemplating keeping a loaded firearm inside their residence, out of fear of the contemplating keeping a loaded firearm inside their residence.

This case will be forwarded to the District Attorney for review.
