The California Supreme Court Marriage Decision--What now?

The last 24 hours have definitely been challenging for California families. Four members of our state's highest court arrogantly decided to impose their social agenda on citizens-in spite of the fact we already decided the definition of marriage through Proposition 22. Understandably, we have received many calls and emails from families expressing their disappointment and frustration about our judiciary and legislature.

While this is a temporary obstacle for our movement, this is when we must reaffirm our resolve and redouble our efforts. Now is not the time to withdraw and cede our culture to tenacious anti-family activists. Standing up for our values is a ministry that is no different than feeding the poor or helping the homeless. This is our ministry: to protect a culture that is a safe and healthy place to raise children and live our faith.

America is unique in the world for establishing a society that balances fundamental rights with individual freedom. But some factions in society want their man-made rights to overrule our freedoms. The court's decision cannot be appealed to the United States Supreme Court so we must overturn our state's judicial activism at the ballot box. This November, we have the chance to reclaim our freedom and our power. In light of the California Supreme Court's outrageous decision, it is essential that we place the traditional definition of marriage in our constitution.

A Sad Day for California: Marriage Officially Redefined

June 16, 2008, will officially be recorded as a somber day for California. This is the day that the timeless, vital institution of marriage was not just redefined, but used to advance a political agenda.

At 5:00 p.m. this evening, homosexuals will legally be allowed to "marry" in government offices throughout the state. Just one month after the California Supreme Court's irresponsible decision to redefine marriage for all of society, homosexuals will ascend upon our state to take advantage of the judicial activism. At least two counties, Butte and Kern, are refusing to marry couples, citing increased costs and staff limitations.

"For American families, and our society as a whole, this is a dark day," stated Karen England, Executive Director of Capitol Resource Institute. "The apolitical relationship that is traditional marriage, which has sustained thousands of years of human existence, has been hijacked to accomplish a shortsighted and ultimately damaging political agenda.

"Homosexual activists contend that this 'civil rights' victory will make our society more 'equal'." But the truth is it will hurt families and the cornerstone relationship on which they rest: monogamous marriage between a man and a woman. If all people were truly equal, then four elitist judges on the California Supreme Court would not have given special privileges to homosexuals over the constitutional rights of all citizens."

homosexual 'marriage' rights out of thin air," stated Meredith Turney, Legislative Liaison for Capitol Resource Family Impact. "They will have their chance to voice their beliefs again in November, when the Protect Marriage Initiative places traditional marriage in the state constitution, safe from judicial activism."

FAQ's about Protect Marriage Initiative

1. Is there anything citizens can do to stop this assault on traditional marriage?

Yes! The Protect Marriage Initiative will place Proposition 22's language in the state constitution. The initiative will be on the 2008 November ballot. In 2000, voters decided by an overwhelming margin that marriage in California would be defined as between one man and one woman. But four activist judges forced their political agenda on citizens by declaring the law created by Proposition 22 unconstitutional. The Protect Marriage Initiative will place the traditional definition of marriage (one man and one woman) in the constitution so that judges cannot overturn the people's will.

2. How many votes will it take to pass the Protect Marriage Initiative?

A simple majority vote-fifty percent plus one. Some people are under the impression that the initiative needs to pass with a 2/3 vote-this is not true. Because the Protect Marriage Initiative is a constitutional amendment, it took more voter signatures to get it on the ballot, but not to actually pass the initiative once it qualified. Therefore, we only need 51% of November voters to pass the initiative.

3. What can I do to help the Protect Marriage Initiative?

Spread the word to everyone you know about this important initiative. Make sure every contact in your email address book is on our email list. This will keep pro-family citizens informed and engaged at this crucial time.

Also, contact your church and make sure it will have a Citizen Sunday table to alert members about the campaign. Every eligible church member should be registered to vote and prepared to vote for Protect Marriage in November.

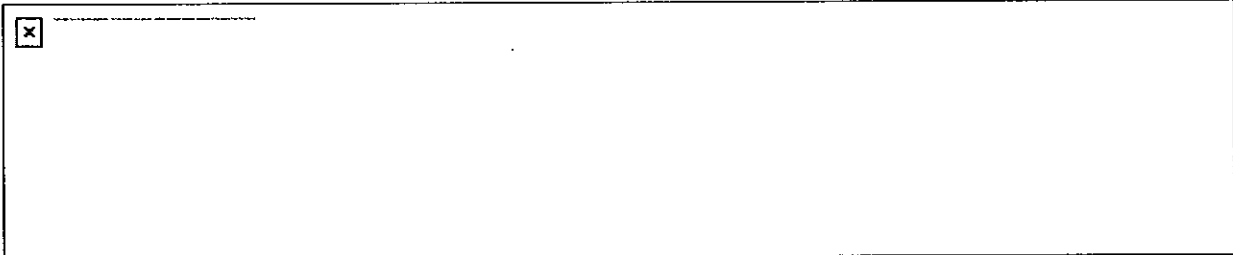

Field Poll Reports Proposition 8 Lagging

The Field Poll released a survey today that reports Proposition 8 is falling behind in public support. 38% of voters expressed support for the Marriage Protection At, while 55% oppose the constitutional amendment. The gap between support and opposition has grown from 9% in June to 17% in September. Part of the new negative results is Attorney General Jerry Brown's biased rewriting of the proposition's title and summary to read "eliminates the right of same-sex couples to marry."

"Polls can be skewed, depending upon how questions are phrased, and we know that polling for marriage amendments historically underreport the level of true support," stated Karen England, campaign manager for Yes on Proposition 8. "There is no doubt that we have an uphill battle; the landscape has changed since Proposition 22. ; However, Californians still support protecting the real definition of marriage: one man, one woman.

And Californians have a history of overturning judicial tyranny at the November ballot box-this November will be no different.

"There are still a significant number of undecided voters in this race," continued England. "It is our job to educate and inform these voters about the consequences of destroying traditional marriage. Marriage's destruction will impact every relationship. We've already seen how a young couple in Placer County is barred by the government from declaring themselves "bride and groom" on their marriage license. And every married couple right now is no longer legally "husband and wife," but "Party A and Party B." Have you and your spouse determined which party you are?"

The next six weeks are historic-they will determine the future of our society. Please do everything you possibly can to help save marriage. Our nation depends upon our commitment and activism.

< BR>**Actor Brad Pitt Donates \$100,000 to No on Proposition 8**

Providing even more evidence that Hollywood's elite are out of touch with the average American, actor Brad Pitt donated \$100,000 to the No on Proposition 8 campaign yesterday.

"Because no one has the right to deny another their life, even though they disagree with it, because everyone has the right to live the life they so desire if it doesn't harm another and because discrimination has no place in America, my vote will be for equality and against Proposition 8," Pitt said Wednesday. He also expressed surprise that Hollywood hadn't done more financially for the No on Proposition 8 campaign.

"Mr. Pitt is obviously an uninformed donor and voter if he fails to understand the ramifications of homosexual marriage in our society," stated Karen England, campaign manager for Yes on Proposition 8. "Homosexual marriage will harm married couples and our nation's children. Redefining marriage means that all marriages will immediately be devalued. Young children will be exposed to all sorts of unhealthy variations on marriage: one man and three women, two men and a woman, and eventually marriage with minors. Destroying the government-transcending definition of marriage will have far-reaching implications that we cannot even predict at this time because no society has ever survived such an anti-social experiment."

Pitt has famously declared that he won't consider marrying the mother of his three children-actress Angelina Jolie-until "everyone else in the country who wants to be married is legally able."

"Perhaps Miss Jolie should reevaluate whether Mr. Pitt is sincere in his intent to marry her," stated England. "All couples have been legally allowed to marry since 1967, when the historic case of Loving v. Virginia ended anti-miscegenation laws. This case recognized that marriage is between one man and one woman, regardless of race. But unlike truly historic civil rights advancements, the homosexual movement wants to completely redefine marriage and twist it into an unrecognizable relationship."

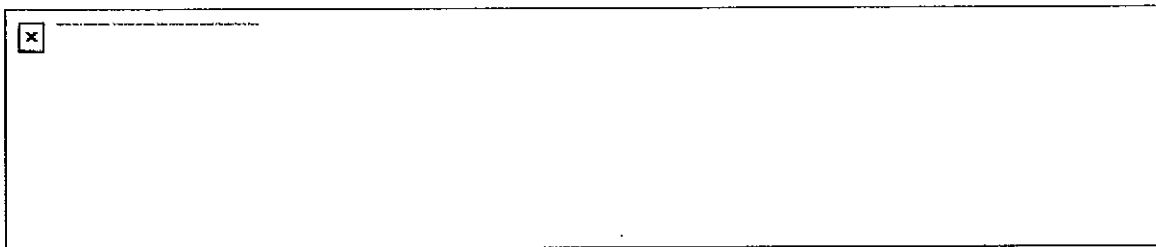

The Consequences of Homosexual Marriage

In the next few weeks Californians will be inundated with media messages about the importance of allowing same-sex marriages. Voters will see TV ads telling them that homosexual love deserves "equality" with heterosexual love. Voters will hear radio reports about how all gays and lesbians want is to have the same "rights" as all married couples. And the main message that will be repeated is that allowing homosexuals to marry will have no impact on your marriage or your family-so what's the harm in giving gays their chance to marry?

Although on the surface these arguments appear convincing, they don't tell the whole truth.

Homosexual marriage will have a direct, intrusive and damaging effect on your family.

Public Schools will teach that homosexuality and same-sex marriage are normal and acceptable-and if you disagree, you are a bigot. Books like "Heather has Two Mommies" or "Daddy's Wedding" will be used to teach

kindergartners about homosexual relationships. When parents in Boston complained about an eighth-grade teacher instructing students about gay sex, the teacher responded, "Give me a break. It's legal now."

Churches will be required to perform homosexual marriage ceremonies or face prosecution under anti-discrimination laws. The California Supreme Court recently ruled that medical professionals may not defer treatment to another professional based on their religious objections. In other words, Christians and those with moral beliefs must check their conscience at the door when they arrive at work. The same case law will apply to churches. Pastors will no longer be allowed to refuse marrying homosexuals based on their religious beliefs.

Businesses will be prosecuted for not participating in homosexual ceremonies: A New Mexico photography company is being prosecuted for refusing to photograph the "commitment ceremony" of a homosexual couple. The full force of the government will be used to make citizens publicly accept homosexuality.

Married couples will no longer be considered "bride and groom," but "Party A and Party B." A young couple in Placer County wrote the terms "bride" and "groom" on their marriage license, which was returned from the state as an "unacceptable alteration." A husband and wife are legally referred to now as Party A and Party B according to the California government. By redefining marriage, every marriage has already been affected.

The role of parents will be diminished. The family unit is already under assault with no-fault divorce, acceptance of single parenthood, and nanny government usurping the role of fathers. Homosexual marriage worsens this trend by giving government approval to single-sex parenting. Children need both a mother and a father. By approving homosexual marriage, government and society denies children their right and need for both parents.

These are just a few of the negative, damaging consequences of allowing homosexual marriage in our society. When you encounter a neighbor, church member, work associate, or family member who says, "I'm not a bigot-and homosexual marriage won't affect me," remind them of just how much it will impact their family and all families.

This is not an issue of bigotry, but of ensuring marriage isn't redefined by four activist judges. Wanting children to be raised by both of their parents isn't bigoted either. What's truly bigoted is telling Christians, Jews, Muslims and other people of faith that their beliefs must be silenced.

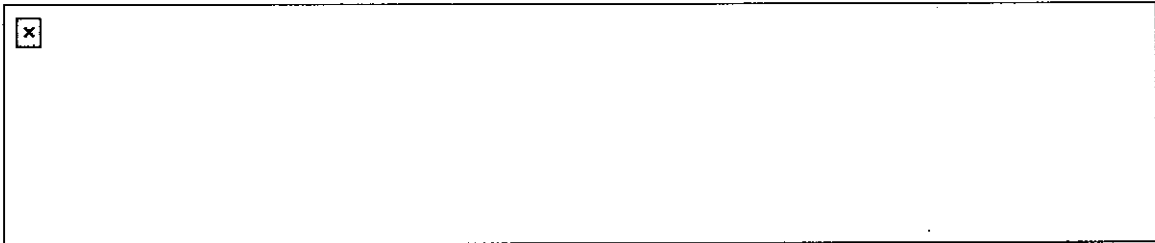

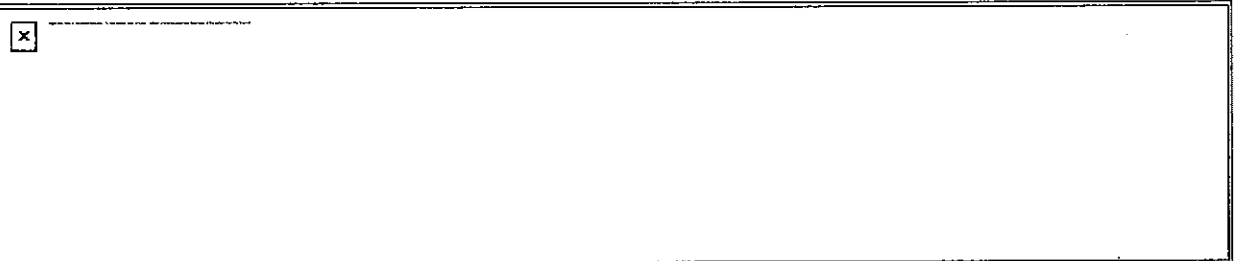

Big Financial Donors Oppose Proposition 8

It doesn't come as much of a surprise that Hollywood is aligning itself against Proposition 8. Tinsel Town is infamous for its programming that undermines family values. A sexually-suggestive, crude message then gives voice to the "beast."

Utility company **PG&E** has thrown its support behind **No on Proposition 8** and **AT&T** has dedicated itself to defeating the ballot measure. **Google**, the most popular internet search engine, last week publicly declared its opposition to Proposition 8. Co-founder Sergey Brin stated, "[I]t is the chilling and discriminatory effect of the proposition on many of our employees that brings Google to publicly oppose Proposition 8. While we respect the strongly-held beliefs that people have on both sides of this argument, we see this fundamentally as an issue of equality. We hope that California voters will vote no on Proposition 8 -- we should not eliminate anyone's fundamental rights, whatever their sexuality, to marry the person they love."

As you can see, we have powerful, wealthy opponents in this battle.

But despite the millions of dollars these few elites are spending to destroy traditional marriage, they cannot match the millions of Californians who want to protect traditional marriage.

New Poll Shows Proposition 8 Gaining Among Young Voters

A CBS 5 (San Francisco) poll released last week indicates that support for Proposition 8 is growing amongst young voters. Among likely voters, the marriage amendment now leads 47-42%. Voters 18-34 support the measure 53-39%.

"This issue isn't about bigotry or ignorance," explained Karen England, campaign director for Yes on Proposition 8. "Young people have grown up in a culture that increasingly devalues the importance of a two-parent home. These young voters crave a society that encourages solid marriages with a mother and father raising their children. The new polling shows that when given a choice, young people will always choose a home with both their mother and father."

College Student Council Supports Proposition 8

The student council at American River College in Sacramento, CA took a bold stand in favor of traditional marriage by voting to endorse Proposition 8. By a vote of 8-3 (with three abstentions) the council members decided to throw their support behind the marriage amendment. In the heart of liberal academia, the decision created a campus firestorm and now nine members of the council will face a recall election for their support of Proposition 8.

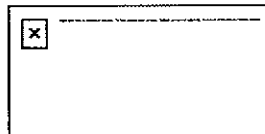

Opponents of Proposition 8 are propagating a lie in their attempt to confuse voters. Their mantra is that same-sex marriage will have no impact on your marriage or family. If only that were true.

Some may argue that this type of prediction about same-sex marriage's impact is just an overreaction. After all, it's been "legal" in California since June. But we're already starting to see the results of redefining marriage.

Just last week a kindergarten class in a public school was taken on a school-approved "field trip" to witness their gay teacher's "wedding" to her partner.

These young, impressionable children were taken from the classroom, where they should have been learning reading, writing and math, to participate in a same-sex marriage ceremony. This is what anti-family forces have in mind when they apply Section 51933 in the classroom.

And the state's largest teachers union, the California Teachers Association, is one of the biggest financial supporters of the No on Proposition 8 campaign. The CTA has given hundreds of thousands of dollars towards defeating Proposition 8. This union has also actively supported homosexual marriage legislation in the legislature in recent years.

We have less than a month to go in this historic, crucial campaign. We need you to keep spreading word of this threat to our families.

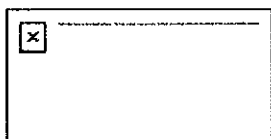

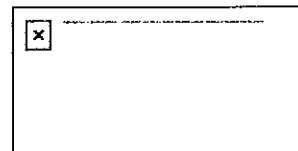

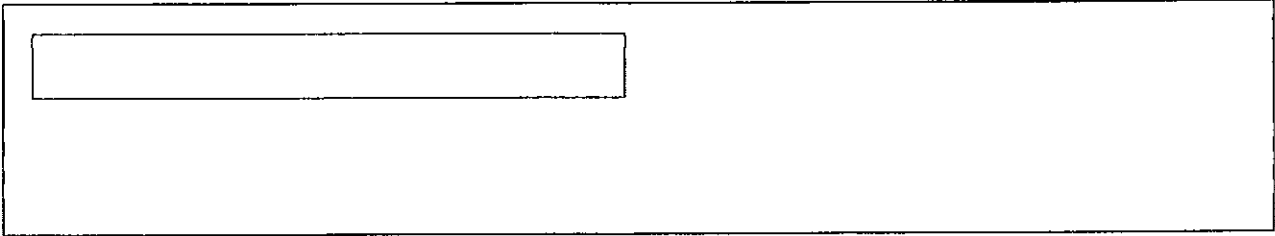
