October / November 2005

Rodney emailed my best friend Casey Douglass to tell her that she ought to get me under control and that she ought to like Rodney better because he's going to be around. The email used derogatory language towards me.

Another email was sent around the same time by Rodney to Casey's boyfriend telling him that Casey was cheating on him - this had no factual basis.

January 2006

Rodney and I agreed to properly exchange (personal items that were left over after I moved out). I asked him to come to a public place and told him I would not come alone. These requests were granted by him but not before 30 plus text messages sent to my phone by him with harassing messages contesting my terms.

"I'm not playing your games"

"You'd better show up or else"

I wanted to cancel because his behavior became so verbally / written hostile.

I ended up taking his personal items
and dropping them off on his back
porch before he was off work. It took
him several more weeks to give me
back my items. I was too afraid
to press the issue.

Summer 2005

I witnessed Rodney take his
daughter from ex-wife's moving
(pulling away) vehicle after some
harsh words between them. He then
called the police and told them
she tried to run him over. That
is not what happened. I was
afraid for his ex-wife because
he was accusing her of domestic
violence. Afterwards, he was very
angry and he took it out on me.
I was too scared to call the police
during his violent bouts because
he would accuse me the way
he falsely accused his ex-wife.

Verbal abuse

Summer + fall 2005

After excessive, daily drinking he
would aggressively pursue me for
sex. He would not harm me
physically, but we would fight

I was trying to get away from him and the house we lived in.

Alcohol abuse:

He drank at least ^{one drink} every day. Most days he drank multiple beers, or glasses of wine, or shots of vodka or tequila.

Drinking made him ask for sex more often than I thought was necessary, and he would not take no without a fight. I usually gave in to stop the fighting. I did not want this sexual activity that was dry and unemotional. We fought about sex more than anything else.
